

Scott County Schools COVID-19 Decision Matrix

Scenario	Mandatory Absence	Return to School
Vaccinated staff or student contact with positive non-household or household member.	<b>None Required</b>	<b>Immediately</b>
Student/staff contact with a positive person while masked. <b>(Mask to Mask)</b>	<b>None Required</b>	<b>Immediately</b>
Student/staff* tests positive for COVID-19 (regardless of symptoms).	<b>Excused absence for 10 calendar days from either: (A) Date test taken for asymptomatic or (B) Date of first symptoms Negative result does not lift 10 days.</b>	After mandatory absence served and person has been sign/symptom free for 24 hours prior to the return to school. Negative test not required for return to school.
Student/staff contact with someone quarantined due to exposure to a COVID-19 positive person (contact of a contact).	Until the quarantined person tests positive, a contact of a contact is cleared to come to school.  Recommended that the contact of a contact demonstrate the highest level of healthy habits.	Immediately.  However, if the situation exists where the supervisor could allow for telecommuting that would be permissible but not required.
Student/staff* with fever OR multiple signs/symptoms of COVID-19 (1 <sup>st</sup> occurrence).	<b>Excused absence rest of current day and excused absence the calendar day that follows. Recommend PCR COVID-19 test.</b>	After mandatory absence served and person has been sign/symptom free for 24 hours prior to return to school.
Student/staff* with fever OR multiple signs/symptoms of COVID-19 (2 <sup>nd</sup> occurrence in 10 days).	<b>Excused absence for 10 calendar days from 1<sup>st</sup> occurrence. Negative result from PCR COVID-19 test takes away 10-day absence requirement.</b>	After mandatory absence is served, unless a negative result from a test is obtained and person has been sign/symptom free for 24 hours prior to return to school.
Unvaccinated Student/staff* <b>non-mask</b> contact with COVID-19 positive household member.	<b>Excused absence for 10 calendar days from either: (A) Date test taken for asymptomatic or (B) Date of first symptoms Negative result does not lift 10 days.</b>	After mandatory absence served and person has been sign/symptom free for 24 hours prior to the return to school. Negative test not required for return to school.
Unvaccinated Student/staff* <b>non-mask</b> contact with COVID-19 positive non-household member.	<b>Excused absence for 10 calendar days from either: (A) Date test taken for asymptomatic or (B) Date of first symptoms Negative result does not lift 10 days.</b>	After mandatory absence served and person has been sign/symptom free for 24 hours prior to the return to school. Negative test not required for return to school.
Vaccinated Student/Staff* with symptoms.	<b>Verified by health official, excused absence rest of current day and excused absence the calendar day that follows. Recommend PCR COVID-19 test.</b>	After mandatory absence served, and released by health official, staff/student can return to campus.

\*Staff must use personal leave time unless they qualify for state allocated COVID emergency days.
