



2021 – 2022 Middle College Application Instructions

Scott College Middle College offers 11th and 12th grade Scott County School District students the opportunity to enroll in college courses that count for high school and college credit, allowing students to get a head start on college which saves students both time and money. Students accepted into Middle College enroll in 15 or more credit hours of college classes each semester. Rising juniors (students beginning 11th grade in fall 2021) can earn an associate degree from BCTC by the time they graduate high school.

To enroll in Scott County Middle College, a student must meet all of the following criteria:

- ✓ Resides in Scott County;
- ✓ Attends a Scott County high school;
- ✓ Meets college readiness benchmarks required to place into Middle College classes;
 - Successful completion of HS Algebra II by May 31, 2021 and one of the following:
 - Cumulative unweighted GPA ≥ 3.0 ; *OR*
 - Cumulative unweighted GPA ≥ 2.5 *and* ACT English ≥ 18 *and* ACT Reading ≥ 20 *and* ACT Math ≥ 22 ; *OR*
 - Cumulative unweighted GPA ≥ 2.5 *and* KYOTE Writing ≥ 6 *and* KYOTE Reading ≥ 20 *and* KYOTE KMATH ≥ 25 (KYOTE KALG ≥ 14 can be used instead of KYOTE KMATH); *OR*
 - Cumulative unweighted GPA ≥ 2.5 *and* MAP Reading ≥ 237 *and* MAP Language ≥ 232 *and* MAP Math ≥ 258 ; *OR*
 - Cumulative unweighted GPA ≥ 2.5 but without ACT scores can email BL-SCMC@KCTCS.EDU to request remote placement testing (Wonderlic and/or KYOTE) no later than April 2, 2021 (placement test results will determine college readiness)
- ✓ Meets course-specific requirements and prerequisites;
- ✓ Completes the application process and submits all required documents **by April 16, 2021.**

BCTC reserves the right to limit Middle College enrollment based on capacity.

Application Process & Required Documents

Students interested in enrolling in the 2021-2022 Scott County Middle College program must complete the following process and submit the required documents by **Friday, April 16, 2021**. **Late applications will not be accepted.**

Step 1: Complete the BCTC Admissions Application. Please complete BCTC's online admissions application for Fall 2021 enrollment. Go to www.bluegrass.edu and click on **Start Your Application**.

- When asked if you are currently enrolled in high school or home school, select 'Yes.'
- Print the acceptance email that includes your KCTCS student identification number (a nine-digit number that begins with 00)

Step 2: Send your high school transcript. Send a copy of your high school transcript to Bluegrass Community and Technical College. The transcript must show your cumulative unweighted GPA.

Step 3: Send your test scores. If you meet college readiness benchmarks using GPA alone, you can skip this step. If you are using ACT scores to meet college readiness benchmarks, please send an official copy of your ACT scores or a screen shot of your ACT scores with your name showing to BL-SCMC@KCTCS.EDU. If you would like to use placement test scores to meet college readiness benchmarks, please contact your school counselor and request that your test scores be sent to BL-SCMC@KCTCS.EDU.

Step 4: Complete and send the Scott County Middle College Enrollment Application. The Scott County Middle College Enrollment Application can be found on the following pages. Complete the application, including student and parent/guardian signatures. Save the completed application as a PDF and email it to BL-SCMC@KCTCS.EDU or print out the completed application, scan it, and email it to BL-SCMC@KCTCS.EDU.
